## Forum Explores Social Justice for Homeless

Scholars, researchers, policy makers, healthcare professionals, educators and advocates will come together to share ideas for alleviating disparities in health and access to health care. "The Face of the Person Who is Homeless" will draw more than 250 participants from 14 states.

**This 10th annual McGinley-Rice Symposium sponsored by Duquesne University School of Nursing will be held on October 17 and 18** and will explore the following themes through the lens of social justice: cause and effects of homelessness, strategies for prevention and short and long-term treatment; clinical and programmatic initiatives to foster healthcare equality for persons experiencing homelessness; consequences of being homeless.

PCGF Executive Director **Pam Golden** will serve on a panel showcasing the collaboration that moved the BigBurgh web app from a concept to a reality. Joining Ms. Golden on the panel will be **Anna Kudrav**, Assistant Chief, Pittsburgh Bureau of Police; **Maurita Bryant**, Assistant Superintendent,



Allegheny County Police Department; and **Dan Palka**, Street Outreach Team Leader, Operation Safety Net. Serving as moderator will be **Joe Lagana**, Ed.D., founder of the Homeless Children's Education Fund.

## Ward Home Joins Forces with Auberle

In July, Ward Home became part of Auberle in an effort to expand programming and enable the organization to benefit from the support of the larger Auberle system. While Ward Home has retained its name and programs, its administrative office has moved to Auberle's main campus in McKeesport.

Ward Home provides programs for youth ages 12 and older living in Allegheny County, providing housing, life skills training and free personal

care items for those who experience the foster care system. Auberle provides a wide range of services to county residents, including emergency shelters, residential programs, behavioral health programs and the 412 Youth Zone, a drop-in center that provides counseling, meals and training services to youth ages 16 to 24.

Both Auberle and Ward Home have received grants from Pittsburgh Child Guidance Foundation. ■
